Comanche Nation Chairman Forrest Tahdooahnippah calls the 2025 Annual General Council meeting to order. All Comanche Business Committee (CBC) members were present. A quorm was established consisiting of 150 tribal members over the age of 18 years old, making the Supreme Governing Body of the Comanche Nation.

The Comanche Nation Chairman, Forrest Tahdooahnippah, called the meeting to order at 1:21 p.m., with a total of 376 enrolled Comanche tribal members registered by 1:41 p.m.

Thomas Narcomey makes a motion to put the KCA resolution he submitted on the meeting agenda. Comanche tribal member Balante Herrera seconded the motion. The motion fails by a voice vote conducted by Chairman Tahdooahnippah.

Comanche elder Nolan Tahdooahnippah makes a motion to change the agenda to put the budget before the program reports. Herrera seconds the motion. The motion

passes per voice vote conducted by Chairman Tahdooahnippah.

Cindy Famero makes a motion to put the Tribal Administrator, Lisa Dawsey, on Administrative Leave pending an investigation. Corolyn Codopony seconds the motion. She explained the resolution

On March 28, Comanche Nation purchased Sure Stav by Best Western, Extended Stay and Arrowhead Apartments north of Comanche Nation Casino in Lawton, Oklahoma. Comanche Nation Chairman Forrest Tahdooahnippah said the funding came from the New Business line item.

"And for the last several years, that line item wasn't touched, and so we had carryover money, and in addition, we have a land acquisition budget, and that also had some carryover, so we used a lot of carryover money to purchase the hotels," he said. "We also borrowed money from a bank to complete the purchase, and we'll be using that new business money if we make any sort of renovations or need capital, but we're also, like I said, looking for investors and partners to help us out with that."

Tahdooahnippah said the hotel will have several changes.

Tahdooahnippah said there would be strict tenant policies for the apartment complex.

"In the short term, we're looking at being stricter on the policies for tenants doing increased background checks and trying to create a more family-friendly, entertainmentfriendly type of atmosphere so that it will augment the casino and the hotel," he said.

Tahdooahnippah said the hotel owners previously owned the Extended Stay, so there was already integration between the two properties.

"Whereas if you rent a room at the Extended Stay, you get half off at the breakfast at the hotel. You can use some of the amenities at the hotel, like the pools," he said. "So, we're really trying to just integrate all three properties, all four properties, really the three that we bought plus the casino, and so we can integrate them so we can cross-market on all four properties."

Tahdooahnippah said the tribe is considering moving the gift shop to the old tourism center.


"And the additional space in the hotel is letting that become possible because the old tourism center has been used by Comanche Nation Casino for some office space and HR functions, and so by buying the hotel, we get more space we can move those functions into the hotel as needed or other locations and then we can move the gift shop back to



Maruaweka Numunuu:

Spring is here, and along with it come feelings of rejuvenation. The grass and trees come back to life, the birds migrate back home, and the weather warms. I also have a feeling of rejuvenation as your Chairman because as I approach my one-year anniversary in office, I can see the seeds planted during the last year start to grow. When I first came into office, the job was largely understanding the situation as it was. What was working? What was not? Once I was able to take stock of the situation, I gave the CBC my assessment and we began working towards solutions.

For any Tribe, economic development, especially gaming, is obviously a primary concern. When I came into office, revenue was on a downward trend, causing a chain reaction of reduced budgets, declining infrastructure, and low morale. We needed to diversify our economy, improve gaming amenities, and enhance accountability. We have done all of these things-we have acquired non-gaming businesses, we are constructing new amenities to gaming and are fixing up our existing facilities, and we have re-instituted a gaming board of directors and expanded our gaming commission. I am confident that we will see our revenue improve as a result of all these changes.

The hardest part of the last year has been transparency. I am committed to transparency, and I know that the change in disclosure has been notable. However, with increased transparency, comes increased disinformation from those that oppose transparency (usually because they are the beneficiaries of previously unexposed favoritism). Nonetheless, I will never shy away from transparency. The Tribal Council is the body that makes the most important decisions. Therefore, the Tribal Council needs all the information to make the best decision, and my guiding principle has always been to simply put out the information and let the Tribal Council make the hard decisions. Social media posts and commentary do not translate to policy. The Tribal Council has the ability to make policy only through the voting process. So please remember to vote on May 17!

the old tourism center," he said. "So, we're really trying to make the entire block of...the long-term vision being just a very fun entertainment-oriented and themed area, a resort destination type thing, increased tourism, increased traffic and kind of work all arms of the tribe. The casino arm, realty department, tribal government, gift shop, everything have worked together to make a great destination location."

Tahdooahnippah said one of the big positives is the hotel's visibility from the highway and easy access. There is still discussion on exact long-term plans; however, he said there have been many great ideas for renovations and improvements.

"There's also been some talk about partners and try to find investors, so we're right now kind of at the stage where we're discussing poten-

tial partnerships," Tahdooahnippah said. "Looking at potential franchises and that sorts of things, and you know, making decisions about what will the real future plan be."

He said tribal members and their families are encouraged to stay at the hotel.

"Every dollar that you spend at the hotel is one that is going back into the tribal economy and helping the tribe itself out," he said. "The hotel has two pools. It has an outdoor pool, it has an indoor pool, it has a complimentary full breakfast with a room stay, and there is a Tribal Member rate. So, if you call to make a reservation and you're an enrolled Comanche, ask about the Tribal Member rate because you will get a discount. There's also discounts for military veterans, those sorts of things."






Hoahwah







Quick Goulash Ingredients

- 11b ground beef (or ground turkey, chicken, or sausage)
- 1 medium onion, diced
- 2 cloves garlic, minced
- 1 can (15 oz) tomato sauce
- 1 can (14.5 oz) diced tomatoes (undrained)
- 1 cup elbow macaroni (or any pasta of your choice)
- 1 teaspoon dried basil (optional)
- 1 teaspoon Italian seasoning
- Salt and pepper to taste .
 - 1 1/2 cups shredded cheese (optional, for topping) Directions
- 1. In a large pot, cook the pasta according to the package directions (about 8-10 minutes). Drain and set aside.
- 2. Brown the ground meat: In a large skillet or pot, heat a little oil over medium heat. Add the ground meat and cook, breaking it up into small pieces, until browned (about 5-7 minutes). Drain excess fat if necessary.
- 3. Saute' the veggies: Add the diced onion to the skillet and cook for about 3-4 minutes, until softened. Add the minced garlic and cook for an additional 30 seconds until fragrant.
- 4. Add the tomatoes and seasoning: Stir in the tomato sauce, diced tomatoes, Italian seasoning, basil, salt, and pepper. Bring to a simmer and let it cook for about 5 minutes to combine the flavors.
- 5. Combine with pasta: Add the cooked pasta into the meat sauce mixture. Stir everything together, making sure the pasta is coated with the sauce. Let it cook for an additional 3-5 minutes, allowing the flavors to meld.
- Optional: Add cheese: If using 6. cheese, sprinkle it over the top of the goulash and cover the pot for 1-2 minutes to let it melt.



Komesetaddle Graduates from Job Core

Pewewardy Key Note Speaker at Northwestern State University; Interviewed by Tahlequah Newspaper

Dr. Cornel Pewewardy was a Keynote Speaker April 10 at Northwestern State University. Lee Guthrie (lguthrie@tahlequahdailypress.com) interviewed Pewewardy for the Tahlequah Daily Press. Some of the article read:

Education is important to ensure the continued sovereignty of Native Americans; otherwise, the story a person hears might be primary or secondary, and it's necessary to get the story "from the horse's mouth."

Dr. Pewewardy, the keynote speaker at Northeastern State University's Symposium of the American Indian, April 10, spoke of his journey in Indigenous studies, how all through his school years, he had only one Native professor.

His talk, "The Hunt for Red Pedagogy," was a power analysis of Gen. Philip Sheridan's American aphorism, "The only good Indian is a dead Indian."

It took Pewewardy six years to get his degree. He said Natives like himself came from families dealing with Post Traumatic Stress Disorder due to boarding schools and fathers going to war.

"My father was a prisonerof-war in the Battle of the Bulge, and he was 19 years old," Pewewar-

dy said. "So I look at you [students] and think about your life, and how would you be? How could you think of everyday life and be lonesome for home and wanting to survive, and where would your water come from, at the age of 19."

That's just one story, and multiply that by 1,000 to where Indigenous peoples are today, and there is much to think about, Pewewardy said.

"That's what reclamation for an Indigenous futures is about – hearing those stories," Pewewardy said.

He stated a disclaimer, that his words had nothing to do with NSU, particularly under the guise of diversity, equity and inclusion. "This is my scholarship, my work, my voice, my doing; because it's my career and I don't want anyone to erase it," Pewewardy said. "There's too many scars, too many promotions and tenure committees I've been on for dissertations, that we don't want to dismiss all of that work."

Leaders of tribal governments, tribal administrators and directors have to be grounded in tribal government and the U.S. government, and that's why he teaches courses on the U.S. Constitution, Pewewardy said.

"We have sovereign constitutions, and we have to understand who put those together," Pewewardy said.

He said sovereign peoples need to decolonize Native constitutions; he doesn't take mainstream leadership classes, because "I don't see that as sacred," Pewewardy said.

"As a sacred scholar you have to be entrenched in commitment to your people and where you are going, not just for the next seven generations, but for the here and now," Pewewardy said. "There's no guarantee you and I will be here tomorrow, so we have to talk about those seeds planted for us [by our ancestors]."
