

***ELECTION / REGULATIONS for
COMANCHE NATION PRINCESS***

- I: The Comanche Nation Princess, hereinafter, referred to as Princess, is an elected official of the Comanche Nation. The Princess is to serve as "Official" ambassador of good will for the Comanche Nation to all other nations and individuals.***
- II: The Princess is to conduct herself in a respectable, courteous and decent manner and she will NOT bring SHAME or SCANDAL to Comanche Nation. The Princess shall promote education and awareness of our traditions and cultural ways.***
- III: -The Princess will be drug free; no substance and/or alcohol abuse.
her application is her agreement to random drug testing
as deemed necessary by the Comanche Tribal Director
-The Princess will be a person of the minimum age of 17 to a maximum age
of 25 and their Comanche degree of blood verified.***
- IV: The CN Princess position will be filled by election process. In the event there is only one (1) or no eligible applicants by deadline; then at discretion of Director a young Comanche girl meeting eligibility requirements may be appointed or application process be re-opened and a new deadline established.***
- V: REMOVAL: The princess may be removed for conduct unbecoming, a felonious act or scandal by the Comanche Nation Tribal Director's written recommendation stating the reasons for the removal action and a unanimous vote of the Comanche Business Committee at an official monthly meeting. ***
(This is to keep this action from "a whimsical" act of any Tribal Director, without justifiable reasons for removal of Princess).***

Length of Reign: From October 1 of the year elected/appointed to September of the following year. Relinquish crown at the Annual Comanche Nation Fair in September.

Application Regulations:

- Submit; to the Comanche Nation Tribal Director by 5:00 p.m. on day of deadline
- short background information w/Blood degree verification
 - a 3 x 5 photo of candidate
 - Valid Photo Identification (containing SS#, address, date of birth)

Application Time and Deadlines:

Deadline should be at least 3 months before September 1. (Set by CN Tribal Director)
News releases WILL be put in CN Newsletter and area newspapers at least 30 days prior to application deadlines.

**REGULATIONS and CODES of
COMANCHE NATION TRIBAL DIRECTOR**

- CODE I:** The Comanche Nation Tribal Director, hereinafter, referred to as Director, is an elected official of the Comanche Nation. The Director will serve under the immediate direction of the Comanche Business Committee. The Director is to serve as "Official" Tribal Liaison, an ambassador of good will for the Comanche Nation to all other nations and individuals.
- CODE II:** The Director is to conduct his/her actions, serve and answer first to GOD our Creator and the Comanche Nation and its "best interests". The Director is to preserve, educate and adhere to all tribal ceremonies, traditions and cultural ways; and will NOT bring shame or scandal in any way by his/her actions or conduct.
- CODE III:** The Director is responsible to supervise and give guidance to the Comanche Nation Princess and Junior Princess. The Director will help and assist them with their schedules, events and representation of our Nation.
- CODE IV:**
- The Director will be drug free; no substance and/or alcohol abuse.
 - The Director will be a person of the minimum age of 35 or older and an enrolled member of the Comanche Nation.
 - The Director will be a person that has NOT been convicted, charged and/or guilty of any FELONIOUS act.
 - The Director will be a person that has NOT been convicted, charged and/or guilty of any acts of Child Molestation, Lude, Vulgar or Violent acts against any other person(s)

Term of Office;

The Director will serve a three (3) year term. In the third year of said term an election will be held during the Annual Comanche Nation Fair in September. The election will be conducted by the Comanche Nation Election Committee, in accordance with these "Regulations and Codes of Comanche Nation Tribal Director" herein. The newly elected Director will begin official duties the first day of January of the year following the election.

Application Regulations:

1. Applicants must submit filing fee and ALL required documents at time of filing for candidacy for Comanche Nation Tribal Director.
2. Submit filing fee and ALL required documents to the Comanche Nation Election Committee office by 5:00 p.m. on day of deadline.
3. Filing Fee is \$75.00 in the form of Money order or Certified check
Payable to: Comanche Nation – to be deposited into the budget line item for the Comanche Tribal Director (previously Expo Director).

Letter requesting to be considered for candidate for Director
CDIB (Certificate of Degree of Indian Blood)

Valid Driver Identification and/or Valid Photo Identification (containing
social security number, address, date of birth)

Signed agreement for background check and drug testing

Application Time and Deadlines:

must file candidacy request for Director by Friday of first full week of June
**(filing period should for 30 days to allow background checks to be completed
by CN Election Board and CN Law Enforcement)**

Applicants must submit filing fee and ALL required documents at time of filing for candidacy for Comanche Nation Tribal Director.

Submit filing fee and ALL required documents to the Comanche Nation Election Committee office by 5:00 p.m. on day of deadline.
