The Court Clerks are prohibited by Ethical Code and Court Rules to provide legal advice and help parties prepare or type court documents. Different situations may require special procedures and the Court Clerks CANNOT advise you on how to proceed or what forms may be necessary in specific situations.

INSTRUCTIONS FOR FILING

IMPORTANT INFORMATION PLEASE READ!!!

- 1. Documents must be Printed or typed and MUST BE LEGIBLE. If the Court is unable to read your documents is may adversely affect your case.
- 2. Documents must be signed in front of the Court Clerk or a notary public when you are ready to file.
- 3. Filing fees, copy fees, etc. can be made by DEBIT CARD, CASHIER'S CHECK or MONEY ORDER and must be payable to "Comanche Nation Tribal Court". Filing fees MUST be paid at the time of filing your petition. If you are unsure of the amount of the filing fees, contact the Court Clerk.
- 4. Submit original Documents, a copy fee will apply to all copies made by the court clerk over 50 pages in length. If the Court Clerk makes your copies, you will be charged a copy fee of \$10.00 for any copies over 50 pages.
- 5. Documents must have the FULL ADDRESS including street, city, state & zip of the parties. Obtaining this information is **your** responsibility.
- 6. Motion forms filed MUST have a copy of the relevant <u>tribal enrollment</u> <u>card/CDIB</u> and be submitted with the Motion when filed. Obtaining these documents is <u>YOUR</u> responsibility.
- 7. Proof of Service of a Motion form is MANDATORY for your case to proceed. Obtaining proof of service is **your** responsibility. Your case will not be set down for a hearing until the Clerk receives proof of service on the parties.
