**RESOLUTION TO AMEND ELIGIBILITY CRITERIA FOR HEADSTONE PROJECT**

**WHEREAS**, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers and privileges to improve the economic, moral, educational, and health status of its members; and

**WHEREAS**, the Comanche Constitution, Article 6, Section 7(f), provides that the Comanche Business Committee has the authority to implement, administer, and report on progress of programs adopted by the Tribal Council; and

**WHEREAS**, by Resolution No. 11-17 the Comanche Business Committee previously adopted the Headstone Project which provides a one-time benefit of either a 12 x 24-inch flat headstone (for deceased Tribal members interred within the boundaries of the KCA Reservation) or reimbursement up to \$300.00 for a headstone (for deceased Tribal members interred outside the KCA Reservation); and

**WHEREAS**, Resolution No. 11-17 required all recipients to have passed prior to January 1, 2005; and

**WHEREAS**, since 2019, the Headstone Project has consistently underspent its budget, suggesting that needs of Tribal members deceased prior to January 1, 2005 are being met; and

**WHEREAS**, the Comanche Business Committee desires to expand the scope of services offered to Tribal members under the Headstone Project.

**NOW THEREFORE BE IT RESOLVED**, the Comanche Business Committee amends the eligibility date for the Headstone Project to January 1, 2023; and

**BE IT FURTHER RESOLVED**, the Comanche Business Committee directs the Tribal Administrator to ensure that Tribal policies and procedures are amended accordingly; and

**BE IT FURTHER RESOLVED**, the Comanche Business Committee, acting for and on behalf of the Comanche Nation, does hereby authorize this Resolution for such intent.

**A RESOLUTION DENOUNCING THE BOOK *EMPIRE OF THE SUMMER MOON***

**WHEREAS**, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

**WHEREAS**, the Comanche Constitution, Article 6, Section 7(f), provides that the Comanche Business Committee has the authority to implement, administer, and report on progress of programs adopted by the Tribal Council;

**WHEREAS**, the Comanche Business Committee has inherent authority to articulate its position on matters of public concern; and

**WHEREAS**, the book *Empire of the Summer Moon: Quanah Parker and the Rise and Fall of the Comanches, the Most Powerful Indian Tribe in American History* by S. C. Gwynne was published in 2010; and

**WHEREAS**, Mr. Gwynne purposefully eschewed use of Comanche sources in writing his book, and as a result of his over-reliance on ethnocentric sources, the book repeats many inaccuracies and stereotypes concerning the Comanche people.

**NOW THEREFORE BE IT RESOLVED**, the Comanche Business Committee hereby denounces the book *Empire of the Summer Moon: Quanah Parker and the Rise and Fall of the Comanches, the Most Powerful Indian Tribe in American History* by S. C. Gwynne; and

**BE IT FURTHER RESOLVED**, all Tribal programs, subsidiaries, departments, divisions, instrumentalities, or other entities receiving Tribal funds are directed to refrain from purchasing copies of *Empire of the Summer Moon* except for purpose of education and/or critique.

**A RESOLUTION AUTHORIZING SETTLEMENT WITH WW BUILDERS**

**WHEREAS**, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved and ratified by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers, and privileges to improve the economic, moral, educational, and health status of its members; and

**WHEREAS**, the Comanche Constitution, Article VI, Section 7(f), provides that the Comanche Business Committee has the authority to implement, administer, and report on progress of programs adopted by the Tribal Council; and

**WHEREAS**, the Tribal Council has adopted a Capital Improvement Program, which generally receives gaming net revenue under the Nation's Revenue Allocation Plan as part of economic development; and

**WHEREAS**, the Comanche Nation, through the Capital Improvement Program, contracted with WW Builders, Inc. ("WW Builders") for WW Builders to build a new building at the Tribal Complex; and

**WHEREAS**, on November 20, 2023, a third-party engaged in fraudulent activity caused a wire payment of [REDACTED] for an invoice to be diverted; and

**WHEREAS**, the fraud was reported to the Federal Bureau of Investigations and an investigation is ongoing; and

**WHEREAS**, through a combination of insurance and recall of the wire, the Comanche Nation was able to make a payment of [REDACTED] of the invoiced amount which was received by WW Builders, leaving a total of [REDACTED] sent by the Comanche Nation but not received by WW Builders; and

**WHEREAS**, the Comanche Nation and WW Builders have a dispute regarding which party should bear the loss due to the fraudulent actions of the third-party; and

**WHEREAS**, the Comanche Nation and WW Builders have otherwise generally had a good relationship and wish to amicably resolve their dispute; and

**WHEREAS**, the Comanche Nation and WW Builders have agreed to resolve their dispute by entering into the Settlement Agreement attached hereto as Exhibit A; and

**WHEREAS**, as described in CBC Resolution No. 127-2024, the Comanche Nation has unspent funds budgeted for economic development in prior years; and

**NOW THEREFORE BE IT RESOLVED** that the Comanche Business Committee hereby authorizes and approves the Settlement Agreement attached hereto as Exhibit A; and

**BE IT FURTHER RESOLVED** that the Comanche Business Committee hereby authorizes the use of prior years' carryover for economic development to pay the settlement amount of [REDACTED] set forth in the agreement, to be paid within thirty days of execution by all parties to the Settlement Agreement.

### TO PROVIDE A 20% DISCOUNT ON COMANCHE NATION TAGS OR STICKERS FOR SENIOR TRIBAL MEMBERS (65+) FOR UP TO TWO VEHICLES, APPLICABLE TO RENEWALS OR GREEN TITLED VEHICLE PURCHASES

**WHEREAS**, the Comanche Nation is a federally recognized Indian Tribe with a Constitution approved by the Secretary of the Interior of the United States on January 9, 1967, to safeguard tribal rights, powers and privileges to improve the economic, moral, educational, and health status of its members; and

**WHEREAS**, the Comanche Constitution, Article V, Section 1 provides that the supreme governing body of the Nation is the Tribal Council; and

**WHEREAS**, the Comanche Tribal Council enacted a General Revenue and Taxation Act (the "Tax Act") by Resolution on April 15, 1995; and

**WHEREAS**, Pursuant to the Tax Act, the Tax Commission developed codes approved by the Comanche Business Committee; and

**WHEREAS**, the Tax Commissioners have approved tribal members who is 65 years (Senior Citizen) and older that is entitled to the privilege of being issued a Comanche nation tag or sticker to be receive a 20% discount for no more than two vehicles per year that is registered in the senior citizen's name. This rule only applies to a renewal and/or purchase of a green titled vehicle. This change will reflect as Paragraph 5 on Page 53 of 121 in the Taxation Act of 1995. The definition, "Senior Citizen" will also be incorporated as Subparagraph (m) on Page 48 of 121 in the Taxation Act of 1995.

**THEREFORE, BE IT FURTHER RESOLVED**, that the Comanche Business Committee hereby approves tribal members who is 65 years (Senior Citizen) and older that is entitled to the privilege of being issued a Comanche nation tag or sticker to be receive a 20% discount for no more than two vehicles per year that is registered in the senior citizen's name. This rule only applies to a renewal and/or purchase of a green titled vehicle; and

**BE IT FURTHER RESOLVED**, the Comanche Business Committee, acting for and on behalf of the Comanche Nation, does hereby authorize this Resolution for such intent.
